# **Final Decision**

In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)

Eskom is intending to construct an 11kV powerline that will provide supply to a customer. The powerline will be 677.44 m in length and is situated near Luckof in the Free State.

Eskom has submitted an application in terms of section 38(1) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) for a proposed 11kv powerline to be constructed on the farm Dundee 416 and Naauwpoort 417, near the Vanderkloof Dam, Free State Province.

The proposed powerline will be 667.44 m long and will be located along existing roads, powerlines, canals and residential areas. The proposed development is located in an area of negligible palaeontological sensitivity as per the SAHRIS PalaeoSensitivity map.

### **Final Decision**

As new line will be built in a highly disturbed area and there are likely no *in-situ* heritage resources, no further assessment of the impact to heritage resources is required as per section 38(2)a of the NHRA.

The following comments are made as a requirement in terms of section 38(2) and 38(4) of the NHRA and must be adhered to:

- 38(4)a The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit has no objections to the proposed development;
- 38(4)b No further conditions are required for the development;
