A Heritage Impact Assessment (HIA) by Exigo (Pty) Ltd was submitted to the South African Heritage Resources Agency (SAHRA) for commenting in terms of section 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA).

The report must comply with the 2012 Minimum Standards: Palaeontological Components of Heritage Impact Assessments.
