LW Consultants have been appointed by Matsapa Trading 529 (Pty) Ltd to conduct an Environmental Authorisation Application for proposed mining activities on a portion of Portion 1 of Farm 431, administrative district of Postmasburg, Northern Cape Province (NC 30/5/1/3/2/10934 MP).

A draft Basic Assessment Report (DBAR) has been submitted in terms of the National Environmental Management Act, 1998 (NEMA) and the EIA Regulations for activities that trigger the Mineral and Petroleum Resources Development Act, 2002 (MPRDA)(As amended). The proposed mining activities will cover 4.6999 ha and will include 3 ha of open cast mining, topsoil and overburden stockpiles, ore dumps, waste dumps, office site, processing plant, ablution facility, parking area, washbay, storeroom, scrapyard, temporary workshop facility, chemical, hydrocarbon and diesel storage, domestic waste facility and access and haul roads.

The DBAR states that it is not foreseen that any archaeological sites will be impacted by the mining operations, however, no assessment that complies with section 38(4) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) as required by section 38(8) of the NHRA and section 24(4)b(iii) of NEMA has been conducted as part of the EA application process.

Any other heritage resources as defined in section 3 of the NHRA that may be impacted, such as built structures over 60 years old, sites of cultural significance associated with oral histories, burial grounds and graves, graves of victims of conflict, and cultural landscapes or viewscapes must also be assessed.
