Final Decision

In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)

Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the powerline for the above-mentioned project. The powerline will include 16 km MV which will be connected to the existing powerline in the area (refer to the Span plan sheets and the Pegging Coordinates for more information) Greater Tzaneen local Municipality of the Limpopo Province.

Eskom SOC Ltd Limpopo Operating Unit (LOU) has submitted a section 38(1) of the National Heritage Resources Act, no 25 of 1999 (NHRA) application, on behalf of their applicant to obtain a SAHRA decision in terms of section 38(2) of the NHRA for the construction of a power line 16900 km in length starting at the Risenga Burgersdorp 22kV feeder, to provide electricity to various Eskom Customer crossing various farms in Gravelotte Village, Greater Tzaneen Limpopo Province.

The SAHRA issued a letter dated 22/06/2022 requesting the submission of an amended .kml file that maps the power line route as it appears in the span plan documents. The case was re-submitted with the amended .kml file.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22kV power line that is within an existing village will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low. However, the area is also located in a low palaeo-sensitivity area and the power line will have negligible impact on the palaeo-heritage.

Final Decision

As the new line will be built in a disturbed area and there are likely no in-situ heritage resources, no further assessment of the impact to heritage resources is required as per section 38(2)a of the NHRA.

38(4)c(ii) - If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Ngqalabutho Madida 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule:

38(4)d – See section 51(1) of the NHRA regarding offenses;

38(4)e – The following conditions apply with regards to the appointment of specialists:

If heritage resources are uncovered during the course of the development, a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued by SAHRA.
