Final Decision

In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)

Eskom Holdings, Limpopo-Mpumalanga Cluster(LIMLANGA) is proposing to build a 406 m MV powerline from the Calcutta 11kV feeder at Mkhuhlu village. The project will be within the Calcutta 294 KU property, Ehlanzeni District municipality, Bushbuckridge Local Municipality, Mpumalanga province. The project will involve the digging of 2X2m and 2,4m deep holes to plant 14m wooden poles and install transformer to supply a high mast.

Eskom SOC Ltd Limpopo-Mpumalanga Operating CLuster (LIMLANGA) has submitted a section 38(1) of the National Heritage Resources Act, no 25 of 1999 (NHRA) application, on behalf of their applicant to obtain a SAHRA decision in terms of section 38(2) of the NHRA for the construction of a 406 m long power line starting at the Mkhuhlu Calcutta 11kV feeder. Eskom is proposing to provide electricity to an Eskom Customer on the farm Calcutta 294 KU, in Matikwane Village, Bushbuckridge Local Municipality of the Mpumalanga Province.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22kV power line that is within an existing village, and along a gravel road will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low. However, the area is also located in a low palaeo-sensitivity area and the power line will have negligible impact on the palaeo-heritage.

Final Decision

The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit accepts application and all the supporting documents for this proposed power line route. Therefore, in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA) the proposed development is granted an exemption from undertaking a Heritage Impact Assessment.

Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999).
