**Permit application submitted in terms of Section 35 of the NHRA (1999) for Site Levelling Activities on Parcels K2 (Erven 115705-RE, 115706, 115707, 115708), N (Erven 10010-RE, 115744, 117884-RE, 177362, 117695, 117891-117898) and P (153779) ahead of Redevelopment, District Six, Cape Town**

Thank you for submitting your permit application in terms of section 35 (4) for Site Levelling Activities related to the above-mentioned land parcels ahead of Redevelopment, District Six, Cape Town.

Please note that SAHRA is a commenting authority for this application and that the final decision must be sought from the competent authority, Heritage Western Cape (HWC) prior to the commencement of activities.

The permit application and motivation submitted to SAHRA for comment indicate that the results of the permit application will be incorporated into the final Heritage Impact Assessment currently being undertaken and submitted to HWC for final approval.

### Recommendations:

SAHRA has no objection to the permit application and the proposed process for the redevelopment:

- The recommendations contained on page 52 of the permit application are supported provided that final approval must be obtained from the competent authority (HWC).
- Comments and recommendations from interested and affected parties consulted as part of this process must be discussed and incorporated into the final HIA.
- It is noted that Iziko will be the curation facility for any significant finds discovered during site leveling. However, no curation letter was uploaded as part of the permit application.
