An amended EMP report has been submitted to SAHRA for commenting in terms of the Minerals and Petroleum Resources Development Act, No 28 of 2002 (MPRDA)(As amended). The proposed listed activities will be 1.8ha in extent on disturbed land currently used as a mine waste dump.

A Heritage Statement by Exigo Sustainability cc has been submitted to SAHRA for commenting in terms of section 38 of the National Heritage Resources Act, no. 25 of 1999 (NHRA).

Chrome Mine application with the case ID 11847. The study area has negligible palaeontological significance as it was underlain by norite and pyroxenite of the Dwars River Subsuite and no assessment of the impact to palaeontological resources is required.

Final Comment

The SAHRA Archaeology, Palaeontology, and Meteorites (APM) Unit notes and accepts the submission of the amended EMPr and Heritage Statement and accepts the recommendations provided by the Heritage Specialist. Furthermore, we grant the development from undertaking an assessment of impacts to palaeontological resources because the area is located within a region that has low palaeontological sensitivity. SAHRA has no objections to the proposed development on the following conditions:

In the unlikely event that fossils are uncovered during construction then construction must cease within the immediate vicinity, a buffer of 30 m must be established, and a palaeontologist called in to inspect the finds. The palaeontologist must obtain a section 35(4) permit in terms of NHRA and Chapter IV NHRA Regulations, before any fossils are collected.

If there are any new heritages resources are discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999). If any unmarked human burials are uncovered and the archaeologist called in to inspect the finds and/or the police find them to be heritage graves, then mitigation may be necessary and the SAHRA Burial Grounds and Graves (BGG) Unit must be contacted for processes to follow (Thingahangwi Tshivhase/Ngqalabutho Madida 012 320 8490).

Once a Record of Decision from the competent authority is issued, it must also be submitted to the case.
