Final Decision

Eskom Holdings, Limpopo-Mpumalanga Cluster(LIMLANGA) is proposing to build a 234m MV and 350m LV powerlines from the Oakley 22kV feeder at Marite village. The project will be within the farm Marite 287 KU, Ehlanzeni District municipality, Bushbuckridge Local Municipality, Mpumalanga province. The project will involve the digging of 2X2m and 2,4m deep holes to plant 14m wooden poles and install 100 kVA transformer to supply households in the area.

Eskom has submitted an application in terms of section 38(1) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) for a proposed electrification of a residential area on the farm Marite 287 KU, Marite Village, Mpumalanga Province.

The proposed powerline will be 234 m and 350 m and will be located in an established village. The development area has been previously disturbed by residential construction, agriculture, roads and fences. The proposed development is located in an area of insignificant palaeontological sensitivity as per the SAHRIS PalaeoSensitivity map.

Final Decision

As the electrification will be built in a disturbed area and there are likely no *in-situ* heritage resources, no further assessment of the impact to heritage resources is required as per section 38(2)a of the NHRA.

The following comments are made as a requirement in terms of section 38(2) and 38(4) of the NHRA and must be adhered to:

- 38(4)a The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit has no objections to the proposed development;
- 38(4)b No further conditions are required for the development;

Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;
- 38(4)c(ii) If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Ngqalabutho Madida 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA.  or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued
 by SAHRA.
