In terms of Section 38(3), 38(8) of the National Heritage Resources Act (Act 25 of 1999)

Notice is hereby given as required in terms of Section 16(4) (b) of the Mineral and Petroleum Resources Development Act (Act No. 28 of 2002) of the submission and acceptance of a prospecting right application by the Regional Manager: Mineral Regulation of the Department of Mineral Resources and Energy (DMRE), Northern Cape Region with reference number: NC 30/5'1/1/2/13098 PR. The application is submitted by Agattu Trading 186 (Pty) Ltd to obtain authorization from the DMRE to undertake prospecting activities for Copper, Gold, Lead, Lithium ore, Tin ore, Rare Earth Elements, Zinc ore and Nickel.

Thank you for notifying SAHRA of the proposed Prospecting Right Application and Environmental Authorisation (EA) Application for prospecting activities on several properties near Kenhardt, Northern Cape Province (NC 30/5/1/1/2/13098 PR).

As the proposed development is undergoing an EA Application process in terms of the National Environmental Management Act, 107 of 1998 (NEMA), NEMA Environmental Impact Assessment (EIA) Regulations as amended, it is incumbent on the developer to ensure that an application specific **Heritage Impact Assessment** (HIA) is done as per section 38(3) and 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) as required by section 24(4)b(iii) of NEMA. This must include an archaeological component, palaeontological component and any other applicable heritage components. The HIA must be conducted **as part of the** EA Application in terms of NEMA and the NEMA EIA Regulations.

SAHRA requests that an assessment of the impacts to heritage resources that complies with section 38(3) of the NHRA as required by section 38(8) of the NHRA and section 24(4)b(iii) of NEMA be conducted as part of the EA process.

The assessment must include an assessment of the impact to archaeological and palaeontological resources. The assessment of archaeological resources must be conducted by a qualified archaeologist and the report comply with the SAHRA 2007 Minimum Standards: Archaeological and Palaeontological Components of Impact Assessment Reports (see www.asapa.co.za or www.aphp.org.za for a list of qualified archaeologists). The standards also refer to a Letter of Recommendation for Exemption for further assessment should the

specialist deem it appropriate.

The proposed development is located within an area of moderate Palaeontological Sensitivity as per the SAHRIS PalaeoSensitivity map. As such, a desktop Palaeontological Impact Assessment (PIA) must be undertaken by a qualified palaeontologist. (See <https://www.palaeosa.org/heritage-practitioners.html> for a list of qualified palaeontologists). The report must comply with the 2012 Minimum Standards: Palaeontological Components of Heritage Impact Assessments. The standards also refer to a Letter of Recommendation for Exemption for further assessment should the specialist deem it appropriate.

Any other heritage resources as defined in section 3 of the NHRA that may be impacted, such as built structures over 60 years old, sites of cultural significance associated with oral histories, burial grounds and graves, graves of victims of conflict, and cultural landscapes or viewsapes must also be assessed.

Further comments will be issued upon receipt of the draft BAR documents inclusive of appendices.
