In terms of Section 38(3), 38(8) of the National Heritage Resources Act (Act 25 of 1999)

GEJ intends to prospect, including bulk sampling, for Attapulgite/Sepiolite (Clay) and Gold Ore over Portion 1 of the Farm Mierhoop 68, Remaining Extent of the Farm Baken Kop 69 and Portion 1 of the Farm Baken Kop 69; and also for Attapulgite/Sepiolite (Clay), Copper Ore and Gold Ore over the Remaining Extent of the Farm Mierhoop 68 and Portion 2 of the Farm Baken Kop 69, situated in the Hay District, Northern Cape Province.

M and S Consulting (Pty) Ltd has been appointed by GEJ Resources (Pty) Ltd to conduct an Environmental Authorisation (EA) Application for the proposed prospecting activities on Portion 1 of the Farm Mierhoop 68, Remaining Extent of the Farm Baken Kop 69 and Portion 1 of the Farm Baken Kop 69; and also for Attapulgite/Sepiolite (Clay), Copper Ore and Gold Ore over the Remaining Extent of the Farm Mierhoop 68 and Portion 2 of the Farm Baken Kop 69, near Bloubospan, Northern Cape Province (NC 30/5/1/1/2/13167 PR).

It is noted that a palaeontological specialist will be appointed to assess the development as par of the EIA phase.

The report must comply with the 2012 Minimum Standards: Palaeontological Components of Heritage Impact Assessments.

Any other heritage resources as defined in section 3 of the NHRA that may be impacted, such as built structures over 60 years old, sites of cultural significance associated with oral histories, burial grounds and graves, graves of victims of conflict, and cultural landscapes or viewscapes must also be assessed.
