## **Final Decision**

## In terms of Section 38(2), 38(4) of the National Heritage Resources Act (Act 25 of 1999)

Attention: Miss Prudence Khosa Eskom Distribution- LOU 92 Hans van Rensburg Polokwane

Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the power line for the above-mentioned project. The power line will include new 2734.2M LV and 288.18M MV, which will T-off from the existing power line in pole number KBK271/13/1 (refer to the Span plan sheets and the Pegging Coordinates for more information). The power line is traversing on the farm of Lonsdale No.537-LS & No. 538-LS in Polokwane Local Municipality of Capricorn District Municipality of the Limpopo Province.

Eskom has submitted an application in terms of section 38(1) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) for a proposed 22kV powerline in the Ga-Mmabasotho Village on the farms Lonsdale 537 LS and Lonsdale 538 LS and Graaf Reinet 535 LS.

The current power line under application will t-off at the KBK 22KV rural feeder and will be supplying electricity to supply to various households in the Ga-Mmabasotho Village. The proposed development is located in an area of negligible palaeontological sensitivity as per the SAHRIS PalaeoSensitivity map.

## **Final Decision**

As the new line will be built in a disturbed area and there are likely no in-situ heritage resources, no further assessment of the impact to heritage resources is required as per section 38(2)a of the NHRA.

The following comments are made as a requirement in terms of section 38(2) and 38(4) of the NHRA and must be adhered to:

38(4)a - The SAHRA Development Applications Unit (DAU) has no objections to the proposed development; 38(4)b - No further conditions are required for the development; 38(4)c(i) - If any evidence of archaeological sites or remains (e.g. remnants of stone-made structures,

indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, charcoal and ash concentrations), fossils or other categories of heritage resources are found during the proposed development, SAHRA DA Unit (Nokukhanya Khumalo/Natasha Higgitt 021 462 5402) must be alerted as per section 35(3) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;

38(4)c(ii) – If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Ngqalabutho Madida 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;

38(4)d - See section 51(1) of the NHRA regarding offenses;

38(4)e - The following conditions apply with regards to the appointment of specialists:

If heritage resources are uncovered during the course of the development, a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued by SAHRA.
