Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the power line for the above-mentioned project. The power line will include new 360M MV, which will T-off from the existing power line in pole number MMI323 (refer to the Span plan sheets and the Pegging Coordinates for more information) traversing on the farm Tshikundu's-MT, in Malamulele Local Municipality of Vhembe District Municipality of the Limpopo Province

Eskom has submitted an application in terms of section 38(1) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) for a proposed 22kV powerline in the Xikundu Village.

The proposed new powerline will be running along an existing gravel road, and in some portions along an existing power line. The current power line under application will t-off at the Malamulele/Mhinga 22KV rural feeder and will be supplying electricity to various households in the Xikundu Village. The proposed development is located in an area of negligible palaeontological sensitivity as per the SAHRIS PalaeoSensitivity map.

Final Decision

As the new line will be built in a disturbed area and there are likely no in-situ heritage resources, no further assessment of the impact to heritage resources is required as per section 38(2)a of the NHRA.

The following comments are made as a requirement in terms of section 38(2) and 38(4) of the NHRA and must be adhered to:

38(4)a – The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit has no objections to the proposed development;

38(4)b – No further conditions are required for the development;

If heritage resources are uncovered during the course of the development, a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued by SAHRA.
