Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the power line for the above-mentioned project. The power line will include new 0.324KM MV which will T-off from the existing power line in pole number VNM168/185/1 & 08B04(refer to the Span plan sheets and the Pegging Coordinates for more information) traversing on the Farm of Harry Smith No 200-LR in Lephalale Local Municipality of Waterberg District Municipality of the Limpopo Province

Eskom has submitted an application in terms of section 38(1) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) for a proposed 22kV powerline in the Maeteletja Village.

The proposed new MV powerline will be 426m and the LV power line will be 2180m running along an existing gravel road. The current power line under application will t-off at the VNM 22KV rural feeder and will be supplying electricity to various households in the Maeteletja Village.

The .kml file maps the proposed power line routes in random places not within the villages which they will be constructed in, the file must be checked and amended to map all the proposed power line routes as they appear in the span plan diagram document.

SAHRA Response to Notification of Development

This application constitutes a section 38 (1) application for approval by SAHRA in terms of the National Heritage Resources Act, no 25 of 1999 (NHRA), as the proposed power line exceeds 300 metres in length. As such SAHRA is providing response in terms of section 38(2) with regards to this application.

SAHRA Archaeology, Palaeontology and Meteorites Unit cannot make an informed decision on this proposed development because the information provided to this case is not enough to determine decisively that heritage resources will not be disturbed or damaged by the proposed power line construction. In order for SAHRA to process this case, The SAHRA requests that an amended .kml file that shows the power line route as it appears on the Span Plan document must be submitted to the case.
