# **Interim Comment**

## In terms of Section 38(3), 38(8) of the National Heritage Resources Act (Act 25 of 1999)

## proposed 75MW Droogfontein Photovoltaic (PV) Solar Energy Facility (SEF), located in Kimberly within the Sol Plaatjie Local Municipality, Frances Baard District Municipality in the Northern Cape Province of South Africa

Sivest SA (Pty) Ltd has been appointed by Mainstream Renewable Power South Africa to submit an application for the extension of a granted Environmental Authorisation (EA) for the 75MW Droogfontein PV Solar Energy Facility, near Prieska, Northern Cape Province (12/12/20/2024/1/1).

The EA was issued on 19 September 2012 and was valid for 2 years. There have been several amendments over the years with regards to the extension of the validity of the granted EA. Currently it is proposed to extend the validity of the EA for another 3 years to ensure the project falls within the Renewable Energy Independent Power Producer Procurement (REIPPP) Programme. It is noted that no change in layout of the development has been proposed.

A letter from a Heritage specialist has been submitted with regards to the extension of the validity of the EA.
