The field-based assessment of archaeological resources must be conducted by a qualified archaeologist and the report comply with the SAHRA 2007 Minimum Standards: Archaeological and Palaeontological Components of Impact Assessment Reports (see <a href="https://www.asapa.co.za">www.asapa.co.za</a> or <a href="https://www.asapa.co.za">www.aphp.org.za</a> for a list of qualified archaeologists).
