# The proposed construction of six in-stream storage dams

ECI Environmental Consultants International (Pty) Ltd has been appointed by African Realty Trust to undertake a Scoping and Environmental Impact Assessment in support of an Environmental Authorisation (EA) in terms of the National Environment Management Act, Act 107 of 1998 (NEMA) for activities that trigger the NEMA EIA 2014 Regulations, for the construction of 6 in-stream storage dams, that will have a total extent of 51.08 ha, located Farm Letaba Estates 525 LT and Portion 0 of the Farm Beaconsfield 530 LT, Greater Letaba Local Municipality, Limpopo Province.

The draft EIAr, it's appendices, including the Heritage Impact Assessment (HIA) report by Shasa Heritage Consultants for the project have been submitted to SAHRA in terms of section 38(8) of the National Heritage Resources Act, 25 of 1999 for commenting.

Roodt, R. December 2022. Heritage Scoping report for the construction of 6 in-stream dams on Letaba Estate 525 LT (dam 1-5) and Portion 0 of the Farm Beaconsfield 530 LT (dam 6), Mopani District, Limpopo.

The author undertook a field assessment and did not identify any heritage resources along the proposed 6 dams. The author recommends monitoring of ground clearance activities particularly where vegetation was dense. The author notes that the study area is in an area of negligible palaeo-sensitivity and no studies are required according to the SAHRIS palaeomap policy.

38(4)b – The recommendations provided by the heritage specialists are supported and must be adhered to. The following additional conditions must be adhered to:

An archaeologist must be appointed to monitor ground clearance activities at Dam 1, 4, 5 and 6 where vegetation was very dense and ground visibility very poor.

38(4)c(i) – If any evidence of archaeological sites or remains (e.g. remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, charcoal and ash concentrations), fossils or other categories of heritage resources are found during the proposed development, SAHRA DA Unit (Nokukhanya Khumalo/Natasha Higgitt 021 202 8660) must be alerted as per section 35(3) of the NHRA. Non-compliance with section of the NHRA is an offence in terms of section 51(1)e of the NHRA and item 5 of the Schedule;

38(4)c(ii) – If unmarked human burials are uncovered, the SAHRA DA Unit (Nokukhanya Khumalo/Natasha Higgitt 021 202 8660), must be alerted immediately as per section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offence in terms of section 51(1)e of the NHRA and item 5 of the Schedule; 38(4)d – See section 51(1) of the NHRA;

38(4)e - The following conditions apply with regards to the appointment of specialists:

i) If heritage resources are uncovered during the course of the development, a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued by SAHRA; The Final BAR must be submitted to SAHRA for record purposes;

The decision regarding the EA Application must be communicated to SAHRA and uploaded to the SAHRIS Case application.
