Final Comment

In terms of Section 38(4), 38(8) of the National Heritage Resources Act (Act 25 of 1999)

The development entails the construction of a ±5km new gravel road that starts at the R325 (14.6 km from Postmasburg), continues in a north-western direction, and ends approximately 130m west of the railway line. The new road will ensure safe transport and hauling from the R325 to the Palingpan Manganese Mine. The new road will be built up in layers of approved material that forms a 10m gravel carriageway for a length of approximately 5km. This material will be sourced from the mine dumps and borrow pits. The design will also include a new intersection on the R325 to accommodate traffic that will use the new service road and a new railway crossing. Stormwater crossings will be placed at regular intervals to accommodate the natural water course and lay of the land.

Lokisa Environmental Consultants have been appointed by PMG Mining (Pty) Ltd to conduct an Environmental Authorisation (EA) Application for the proposed new haul road and stormwater management for the Palingpan Manganese Mine near Postmasburg, Northern Cape Province (REF: NC/BA/03/ZFM/TSA/POS1/2023).

A Final Basic Assessment Report (FBAR) has been submitted in terms of the National Environmental Management Act, 1998 (NEMA) and the 2017 NEMA Environmental Impact Assessment (EIA) Regulations. The proposed development will include the construction of a ±5 km gravel road, new intersection, new railway crossing and stormwater crossings.

Prof Marion Bamford and Prof David Morris have been appointed to provide heritage specialist input as part of the EA in terms of section 24(4)b(iii) of NEMA and section 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA).

include trace fossils such as stromatolites, however, the project area is covered in red sands and soils. The PalaeoSensitivity as shown in the SAHRIS map is contested and is recommended to be moderately sensitive. A Fossil Chance Finds Procedure is recommended to be implemented.

A total of three heritage resources were identified with the proposed development footprint. These include isolated Stone Age lithic surface scatters of low heritage significance. A Chance Finds Procedure is recommended to be followed.

Final Comment

Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule:
- 38(4)c(ii) If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Ngqabutho Madida 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;
- 38(4)d See section 51 of the NHRA regarding offences;
- 38(4)e The following conditions apply with regards to the appointment of specialists:
- With reference to the mitigation work noted above, a qualified archaeologist must be appointed to undertake the work in terms of the permit applied for as noted above;

 inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological
 or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued
 by SAHRA;
- The Final BAR and EMPr must be submitted to SAHRA for record purposes;
- The decision regarding the EA Application must be communicated to SAHRA and uploaded to the SAHRIS Case application.
