The Struisbult PV2 facility was issued an Environmental Authorisation during 2013 by the Department of Forestry, Fisheries and the Environment (DFFE Ref: 12/12/20/2502). The Applicant wishes to extend the validity of the EA to allow the project to bid in future renewable energy tenders. In support of this, the DFFE has requested that additional information and motivation be provided. A motivation report has been prepared and is available for review and comment on the EIMS website as per the link below. Condition 13 of the EA issued for this development also required updates to be made to the EMPr. The EMPr has been updated and is available for review and comment on the EIMS website as per the link below.


EIMS was appointed by Stuisbult PV2 (Pty) Ltd to submit an application for the extension of a granted Environmental Authorisation (EA) and the update of the EMPr for the Struisbult PV2 facility on the farm Struisbult, near Copperton, Northern Cape Province (DFFE Ref: 12/12/20/2502).

The EA was issued in 2013 and has undergone several amendments including several EA extensions. Currently, it is proposed to extend the validity of the EA to ensure the project falls within the Renewable Energy Independent Power Producer Procurement (REIPPP) Programme. It is noted that no change in layout of the development has been proposed.
