Final Comment

In terms of Section 38(4), 38(8) of the National Heritage Resources Act (Act 25 of 1999)

The prospecting work programme will be designed in phases, each phase conditional on the success of the previous phase and will include: Ø Data acquisition and a Desktop study Ø Target Generation and Ground Truthing; and Ø Scout Drilling and Delineation Drilling

Thevha Sustainable Services (Pty) (Ltd) has been appointed by Wondoko Trading (Pty) Ltd to undertake an Environmental Authorisation Application for proposed prospecting activities on Portion 0 of the farm Wildebeestkuil 69, near Kimberley, Northern Cape (NC/30/5/1/1/2/13279PR).

A Final Basic Assessment Report (FBAR) has been submitted in terms of the National Environmental Management Act, 1998 (NEMA) and the EIA Regulations for activities that trigger the Mineral and Petroleum Resources Development Act, 2002 (MPRDA)(As amended). It must be noted that the Draft BAR was not submitted to SAHRA for review. The proposed prospecting activities will include 10 boreholes, possible trenching and/or pitting (90 m²), site camp, ablution facilities, site offices, storage areas within an application area 6 623 ha.

REACH Archaeology has been appointed to provide heritage specialist input as part of the EA process as per section 24(4)b(iii) of NEMA and section 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) that complies with section 38(3) of the NHRA.

Matabane, M. 2023. Draft Phase 1: Heritage & Archaeological Impact Assessment Report: Notification of Application for Prospecting Right Application for Diamonds (Alluvial and General), on Wildebeest Kuil 69, situated within the Magisterial District of Kimberley, Northern Cape Province

The desktop assessment found that the proposed development footprint is adjacent to the Wildebeestkuil Rock Art Provincial Heritage Site, numerous farmsteads, one potential archaeological site, possible burial grounds and a medium-low probability of rock art sites are located within the development footprint.

- The eastern extent of the proposed site has a HIGH Palaeontological rating. A complete Palaeontological Impact Assessment (PIA) is recommended to be undertaken by a qualified Palaeontologist with necessary procedures and mitigation recommendations developed and proposed;
- A full-scale- Phase II HIA/AIA is recommended to appropriately record, document and analyse flagged, areas of interest and topographically noted possible heritage sites and features.

It must be noted that the results of the HIA have not been included in the FBAR.

In a Final Comment issued on the 08/05/2023, SAHRA objected to the application as theimpact to heritage resources had not been fully assessed as part of the EA process. Since the issuing of the Final Comment, a PIA and revised DBAR have been submitted for review (28/06/2023).

Bamford, M. 2023. Palaeontological Impact Assessment for the prospecting right application for Farm Wildebeest Kuil 69, northwest of Kimberley, Northern Cape Province

The proposed development area is underlain by non-fossiliferous sediments of the Allanridge Formation, the highly fossiliferous Prince Albert Formation and Quaternary calcretes and moderately fossiliferous sands of the Gordonia Formation. No fossils have been recorded in the area and a Fossil Chance Finds Protocol is recommended to be implemented as part of the EMPr.

The revised BAR notes that at this stage 8 drill holes have been targeted during phase 3, and trenches (90m²) and pits will be dug during Phase 4, with a boxcut during Phase 5 of the Prospecting works programme.

Final Comment

- 38(4)a The SAHRA Development Applications Unit (DAU) has no objections to the proposed development with exceptions as noted below;

- Once the locations of the drill sites, site camp, ablution facilities, site office and storage areas are
 established, an archaeologist must survey each location and compile an HIA to be submitted to
 SAHRA for review and comment prior to construction. No construction activities may occur without

activities commencing, a Visual Impact Assessment must be conducted on the impact of these
activities on the Wildebeestkuil Rock Art site. A heritage specialist must use these results to compile an
updated HIA which must include a field assessment and the results of consultation with the
Wildebeestkuil Rock Art Center staff and other interested and affected parties. This updated HIA must
