## Proposed prospect for salt containing brine from 3 pans. Northern Cape

Site Plan Consulting has been appointed by Transalt (Pty) Ltd to undertake an Environmental Authorisation Application for proposed prospecting activities on the remainder and portion 1 of the farm Vilander 381, and portion 112 and 158 of the farm Kalahari-Wes 251, near Upington, Northern Cape Province (NC30/5/1/1/2/13638PR).

A Draft Basic Assessment Report (DBAR) has been submitted in terms of the National Environmental Management Act, 1998 (NEMA) and the EIA Regulations for activities that trigger the Mineral and Petroleum Resources Development Act, 2002 (MPRDA)(As amended). The proposed prospecting activities include three auger holes per pan, a total of nine auger holes.

Dr John Pether and the Agency for Cultural Resources Management were appointed to provide heritage specialist input into the EA process in terms of section 24(4)b(iii) of NEMA and section 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA).

The proposed development footprint is underlain by the Goeboe Goeboe Formation, however the Karo bedrock beneath the pans is expected to be weathered and unlikely to yield well-preserved fossils. A Chance Fossil Finds Procedure is recommended to be implemented.

Heritage resources identified within the surrounding areas include Stone Age lithic scatters of low heritage significance. The proposed development activities do not pose a threat to heritage resources. No further heritage studies are recommended.

- i) If heritage resources are uncovered during the course of the development, a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued by SAHRA;
- The Final BAR must be submitted to the SAHRIS application for record purposes;
