SAHRA received your application to relocate 65 graves within the Mogalakwena Mine that will be adversely affected by the Mogalakwen Mine NWRD project, located on farms Overysel 815 LR, Zwartfontein 818 LR, Blinkwater 820 LR and Sandsloot 236 KR, in the Mogalakwena Local Municipality, of the Limpopo Province.
