Thank you for sending SAHRA the above report assessing the status of the Spitskop 1 Rock Art Site (also known as Baboon Rock) and providing management guidelines for the sites continued conservation.

The rock art site under assessment is situated on a rocky, sandstone outcrop, surrounded by grassland within commercial pine and gum plantations under the management of Komatiland Forests. Rock art is present on two separate rocks at the site - one small and one slightly bigger. Both panels are exposed to the elements and have faded significantly. Vegetation is growing in between the rocks with the paintings, and there is evidence of uncontrolled visitation.

SAHRA commends you on the pro-active approach you have taken towards managing the heritage resources on your property and is in support of the management guidelines proposed in the above report.

In addition, SAHRA requests that an annual report be submitted to SAHRA that outlines the findings of the proposed annual audit by the heritage specialist on the state of conservation of the Spitskop 1 site.
