Thank you for informing SAHRA of the proposed upgrades and associated construction related to the proposed Swaziland Rail Link Project. The proposed upgrade will include doubling of the line, new alignments that may fall outside of the rail reserve, realignment within the rail reserve as well as formation repairs.

The submitted Heritage Assessment identified a number of structures that are likely to be impacted by the proposed upgrade including railway stations and associated infrastructure, bridges as well as stone culverts. No information was provided in the submitted assessment as to whether or not these identified structures would be impacted by the proposed development.

One formal and six informal burial grounds were identified. The formal burial ground is unlikely to be impacted by the proposed development. However, the six informal burial grounds were all located within or directly adjacent to the railway servitude and are therefore likely to be impacted by the proposed development. According to the submitted report, no archaeological resources were identified that may be impacted by the proposed development.

It is noted that no assessment of impacts to palaeontological resources has been submitted to SAHRA. The proposed development is situated within an area of very high palaeontological sensitivity and as such, it is very likely that significant palaeontological heritage resources will be impacted by the proposed development.

Interim Comment

SAHRA is unable to issue a final comment on the likely impact of the proposed development on heritage resources as insufficient information has been provided. As such, SAHRA requires that;

- Due to the likely impact to significant palaeontological heritage, a field-based palaeontological impact assessment be conducted. This assessment must include a protocol for chance finds.





- The informal burial grounds identified in the heritage assessment may not be impacted by the proposed development and should be clearly demarcated throughout the construction phase. A Conservation Management Plan for the continued preservation of the burials must be drafted.
- Any impact to the identified structures requires a permit from the Mpumalanga Provincial Heritage Authroity.
