Van Schalkwyk, J. September 2013. *Cultural Heritage Impact Assessment for the proposed township development on a section of the Farm Kakamas Suid 28, Marchand.*

The above HIA was submitted for the proposed expansion of the existing Marchand township by infill residential development. According to the report, an existing informal settlement occupies most of the study area.

The heritage report identified no heritage resources likely to be impacted by the proposed development. In addition, the study area falls within a geological area of low palaeontological sensitivity and as such, it is unlikely that significant heritage resources will be impacted by the proposed development.

It is noted that the Draft BAR has not been submitted to SAHRA for assessment.

Final Comment

SAHRA has no objection to the proposed development on heritage grounds. Please upload the Draft BAR to this case on SAHRIS as soon as possible.

Should any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, marine shell and charcoal/ash concentrations), unmarked human burials, fossils or other categories of heritage resources are found during the proposed activities, SAHRA APM Unit (Jenna Lavin/Colette Scheermeyer 021 462 4502) must be alerted immediately, and a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contacted as soon as possible to inspect the findings. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance a Phase 2 rescue operation might be necessary.
