# **Sand Mine Dikgat**

We have received notification of your application for an environmental management plan in respect of a proposed sand mining operation on the Farm Dikgat 195 East of Kleinzee in the Northern Cape.

In terms of Section 38(8) of the National Heritage Resources Act (Act 25 of 1999), any proposed development that requires an application in terms of NEMA or the MPRDA must have an assessment of impacts to heritage resources completed as part of the application process. The relevant heritage authority must determine whether the assessment done in terms of impacts to heritage resources satisfies our requirements and must provide comments or recommendations to the decision-making authority.

According to the information provided in this EMP, it is unlikely that any impacts on significant heritage resources will result from the limited sand mining proposed, due to the small area to be disturbed. However, significant stone artefacts are known from river beds such as these and significant archaeological findings are known to be present on the property, which was assessed in 2012 for the proposed establishment of the Blue Wind energy facility. In the event that such artefacts or shell middens are identified, SAHRA and a professional archaeologist must be contacted immediately.

Consequently, SAHRA Archaeology, Palaeontology & Meteorites (APM) Unit has no objection to the proposed sand mining on the condition that if any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, **stone artefacts, ostrich eggshell fragments**, marine shell and charcoal/ash concentrations), unmarked human burials, **fossils** or other categories of heritage resources are found during the proposed activities, SAHRA APM Unit (Jenna Lavin/Colette Scheermeyer 021 462 4502) must be alerted immediately, and a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contacted as soon as possible to inspect the findings. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance a Phase 2 rescue operation might be necessary.
