Thank you for the letter regarding the change in the location of the reburial site for human remains uncovered at Site ID DR-001, also known as Site ID Richmond Road - Dwars Rivier, on farm Dwars River 372, near the Two Rivers Platinum Mine, Limpopo Province. The human remains uncovered at the site underwent C14 analysis (Permit #3448) and it was concluded that the two males remains were dated to 1156-1270AD and 1179-1272AD respectively. DNA analysis showed no relation to the initial claimants.

The request to rebury the remains at the Anglo American Platinum (AAP) Mototolo Der Brochen cemetery situated on the Farm Mareersburg 8JT, Greater Tubatse Local Municipality, Limpopo Province is granted. The permit will contain additional conditions regarding the reburial that must be adhered to.
