Your revised EMP received 11 February 2014 refers;

SAHRA acknowledges the changes made in the revised EMP as per our letter dated 6 February 2014. However, SAHRA notes some concerns.

On page 9, it is indicated that "No sites of archaeological or cultural interest were identified". This is incorrect as no assessment of impact to heritage resources has yet been made. Please amend this to reflect that no assessment has yet been completed and that heritage resources will be identified in the impact assessment to be completed before drilling commences.

On page 20, certain "standards on the protection of national heritage resources" are described. Please note that this section is incorrect and requires amendment. Heritage resources such as structures older than 60 years, archaeological resources, palaeontological resources, meteorites as well as burial grounds and graves are generally protected in terms of the National Heritage Resources Act (Act 25 of 1999), and not only National Heritage Sites. As such, any impact to these resources requires a permit from the relevant heritage authority.

In addition, it is not the responsibility of the miner to determine if a heritage resources will be impacted by the proposed activity, rather it is the responsibility of the heritage authority to ensure that no sites of heritage

significance are impacted by the proposed activity. The heritage authority does this by means of a heritage impact assessment as per Section 38 of the National Heritage Resources Act (Act 25 of 1999).

SAHRA is therefore unable to grant the requested exemption from conducting the necessary heritage studies prior to authorisation from the DMR.

Please submit a revised EMP to SAHRA for assessment that deals with the concerns expressed above.

SAHRA looks forward to receiving this revised assessment before issuing a Final Comment on this matter.
