Thank you for informing SAHRA of Eskoms proposed CSP Integration Project. The proposed project involves linking the approved CSP Solar Park and the Ferrum, Aries and Niewehoop substations using 400kV power lines. The 400kV power line will cover 200km from the CSP to the Ferrum substation at Kathu and 70km from the CSP to the Niewehoop substation in Kenhardt. Two 400kV lines are proposed to cover the 100km between the CSP and the Aries substation in Kenhardt. The 400kV power line has a servitude of 55m and the average pylon is 33m high. The CSP Integration Project will also require the development of support infrastructure and upgrades to the various substations.

The submitted HIA assessed a corridor of 2km around the various alternative routes proposed for the above lines. The report identified a number of Later Stone Age scatters, as well as agricultural infrastructure, both of low heritage significance. The report also identified two possible grave cairns and the Olifantshoek cemetery of high heritage significance.

It is noted that the area proposed for development is underlain by geological sediments that have low palaeontological sensitivity and as such, it is unlikely that significant palaeontological resources will be impacted by the proposed development.

According to the HIA, Alternative route 3 is preferred for the CSP to Aries substation power line on heritage grounds. Alternative route 2 is preferred for the CSP to Niewehoop substation powerline and both Alternative 2 and Alternative 3 are equally preferred for the CSP to Ferrum power line on heritage grounds. It is noted that the HIA recommends that the final selected power line routes be subject to a Final Walkdown by an archaeologist.

Final Comment

Based on the submitted information, SAHRA has no objection to the proposed development as it is unlikely that significant heritage resources will be impacted on condition that;

- The identified possible grave cairns and the Olifantshoek cemetery are not impacted by the proposed development. These heritage resources must be clearly demarcated during the construction phase. Any

impact to these resources will require a permit from SAHRA.

- Placement of infrastructure should avoid sites of high archaeological sensitivity such as pans, rocky ridges and river beds.
- A Final Walkdown of the selected routes is required as per the recommendations in the submitted HIA.
- Should any evidence of archaeological sites or remains (e.g., remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, marine shell and charcoal/ash concentrations), rock art, unmarked human burials, fossils or other categories of heritage resources be found during the proposed activities, or in any future activities, SAHRA APM Unit (Jenna Lavin/Colette Scheermeyer 021 462 4502) must be alerted immediately, and a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contacted as soon as possible to inspect the findings. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance a Phase 2 rescue operation might be necessary.
