The application relates to the closure and decommissioning of the Leeudoringstad landfill site located on the Remaining Extent of Portion 54 of the Farm Rietkuil 43-HP. North West Province. The site is currently not managed and access is uncontrolled. The landfill is situated in previous borrow pits whilst some waste is also disposed in the open veld. The site is 3.3 hectares in extent.

Due the nature of this project and the fact that the area is already in a disturbed context, SAHRA has no objection to the proposed development on condition that, if any new evidence of archaeological sites or artefacts, palaeontological fossils, graves or other heritage resources are found during rehabilitation, SAHRA or an archaeologist must be alerted immediately.
