Morris, D. August 2005. Phase 1 Archaeological Impact Assessment for De Beers Consolidated Mines Ltd (Contract 0616-AC-244-05) to Evaluate Heritage Resources on Properties as Indicated

Several portions of De Beers Kimberley Mines' surface right areas and mining rights have been sold to Crown Resources (Pty) Ltd in two phases recently completed. The EMP submitted to SAHRA for comment provides detail on the purchase agreements as part of this sale. It is noted that the EMP pertains to an existing, fully operational mine and no new expansion projects are proposed for the near future. It is also noted that mining in this area commenced more than 100 years ago. As such, no impacts associated with construction are anticipated.

The above HIA is referenced in the Environmental Impact Assessment Report included in the submitted EMP. It is noted that this HIA dates back to 2005 and is therefore likely to be outdated. The HIA identifies a number of heritage resources that were likely to have been impacted by mining including an Earlier Stone Age (Acheulean) horizon and a historical horizon associated with the development of Kimberley. Specific heritage resources identified include stone walled features and historical middens associated with the original Du Toitspan village on Farm Dorstfontein of high heritage significance, a historic refuse midden on Farm Vooruitzicht 81 of medium to high significance and a historic refuse midden on Kenilworth Estate of medium significance. No information is provided as to the current state of any of the heritage resources identified in this report dated to 2005.

It is noted that no assessment of impacts to palaeontological heritage has ever been completed for this area. According to the submitted documentation, the mine is underlain by rocks of the Karoo Supergroup comprising Karoo shales such as the Ecca Group and dolerite. The Ecca Group is known for its moderate palaeontological sensitivity due to its non-marine trace fossils, vascular plants (including petrified wood) and palynomorphs of Glossopteris flora, mesosaurid reptiles, fish (including microvertebrate remains, coprolites),

crustaceans, sparse marine shelly invertebrates (molluscs, brachiopods), microfossils (radiolarians etc) and fossil insects.

As such, please provide SAHRA with the following;

- An updated HIA report on the current state of heritage resources within the mine area, including, but not limited to, the heritage resources identified in the above HIA.
- A Desktop Palaeontological Impact Assessment that provides a protocol for accidental finds of fossils with palaeontological significance.

SAHRA will await this requested information before commenting further.
