Dr van Schalkwyk undertook a field assessment of the proposed Sports Centre development in Palm Springs. The aim of the investigation was to find and document any possible heritage resources that may be located on the proposed development land area. The investigation did not uncover any heritage resources.

The proposed development lies in a moderate palaeontological sensitive zone (<http://www.sahra.org.za/sahris/map/palaeo>), which a Palaeontology desktop assessment is required for the study area.

Interim Comment

SAHRA agrees with the recommendations made in the Heritage Impact Assessment report.

However before a final comment can be issued by SAHRA APM Unit, then a Palaeontological Desktop Assessment should be conducted by a suitably qualified professional palaeontologist.
