# The proposed development will entail construction of a new Transnet 5MW 3kV DC Traction Substation wherein Eskom will provide 132kV AC which will be stepped down to 3kV DC.

Transnet Freight Rail proposes to construct a 5MW 3kV DC traction substation as part of the Ermelo Richards Bay Railway project. The construction will include the substation and a 132kV transmission line all on Transnet land that is 5600m<sup>2</sup> located on Portion 4 of the farm Tweefontein 458 JS, Steve Tshwete Local Municipality, Mpumalanga Province.

Under sections 34, 35 and 36 of the National Heritage Resources Act (25 of 1999) heritage resources are protected. These resources are for instance burial grounds, unmarked and marked graves that are older than 60 years, built structures that are older than 60 years old, archaeology (stone tools, stone walled sites, prehistoric and historic pottery sherds, ash grounds etc.) and palaeontology (fossils of plant and animal material).

SAHRA Archaeology, Palaeontology and Meteorites Unit requires the development to commission a Palaeontological Impact Assessment (PIA) because the palaeontological sensitivity of the area is *Very High and the* underlying geology of proposed location consisting of shales and sandstone of the Vryheid Formation which may be fossiliferous (<a href="http://www.sahra.org.za/sahris/map/palaeo">http://www.sahra.org.za/sahris/map/palaeo</a>).
