SAHRA notes that the comments have been carried through to both EMPr documents as requested however there are some inconsistencies in sections 3.8 of the Grid Connection EMPr. The development is located in the North West Province and not the Eastern Cape as such SAHRA needs to be notified and not EC Provincial Heritage Resources Agency.

SAHRA will issue further comments on this development once the HMP is amended to include the additional information as outlined in the Interim Comment dated 22 June 2016.
