Proposed construction of approximately 4km of Koria-Boesmanksop 22kv powerline with wooden pole structures. The line is planned to be constructed on the Farm Workshop 97, portion 2 in the Van Stadensrus area, Naledi Local municipality which us part of the Xhariep District Municipality, Free State Province.

An application was made in terms of section 38(1) of the NHRA for the proposed development of a 3873.93 m 22KV powerline on the farm Workshop 97 portion 2 in Virginia in the Free State.
