Tomose, N. April 2014. A Heritage Impact Assessment Study Of Ngwedi Turnings Eskom Deviations As Part Of Ngwedi Turn-Ins Transmission Powerlines, North West Province, South Africa

SAHRA Archaeology, Palaeontology and Meteorites Unit issued a Final Comment dated 19/01/2015 (Case ID 992) for the proposed Eskom Ngwedi Turn-Ins project. SAHRA requested a deviation of the power line to avoid impact on significant archaeological resources.

SAHRA has no objection to the proposed power line deviation based on the findings of the report submitted to SAHRA. However, before the project may proceed the recommendations below must be implemented.

Recommendations:

1. SAHRA has no objections to the proposed deviation provided that no heritage resources that were identified during the walk-through must be impacted.
2. Construction activities must be monitored by an appropriately experienced archaeologist to prevent accidental damage to yet undiscovered heritage resources. If any significant heritage resources are found during construction activities SAHRA must be notified immediately and a Phase 2 mitigation assessment may be required.
3. A monitoring report must be submitted to SAHRA at the end of the monitoring schedule.
