Final Comment

In terms of Section 38(8), 38(4) of the National Heritage Resources Act (Act 25 of 1999)

Attention: Anglo American Platinum Amandelbult

The Amandelbult Concentrator Complex has an existing approved and operational Chrome Recovery Plant. However, this existing Chrome Recovery Plant is not designed to recover fine chromite (-100 µm fraction). An initiative was therefore identified in which an increased recovery of chromite can be realised at Amandelbult through the beneficiation of fine chromite from the Concentrator tailings. It is envisaged that the additional recovery of metallurgical and/or chemical grade chromite will result in an increased yield of chromite for Amandelbult, as well as reduced water losses associated with the existing approved tailings dams. The proposed FCR Plant project will add limited infrastructure to the extensive Amandelbult Complex and will further utilise the existing facilities

Anglo American Platinum (Platinum) Rustenburg Platinum Mines (RPM) appointed SRK Consulting South Africa (Pty) Ltd to conduct the environmental authorisation process for the proposed Fine Chrome Recovery (FCR) Plant project.

This Draft Environmental Impact Assessment (EIA) Report has been submitted in terms of the National Environmental Management Act (NEMA), 1998 and the NEMA 2014 Regulations (As amended), the National Environmental Management Waste Act (NEMWA), 2008, and the Mineral And Petroleum Resources Development Act, 2002 (MPRDA) (As Amended).

The proposed Plant will be located on the farm Amandelbult 383 KQ Portion 0, located 15 km north northeast of Northam and 30 km south southwest of Thabazimbi in both the Thabazimbi Magisterial District and Waterberg District Municipality, Limpopo Province. The total extent of the farm is 1482.6683 Ha, and the extent of the FCR Plant will be 5 Ha and the product pads 1 and 2 will be 4 Ha.

Concentrator tailings steams of the UG2 #2, UG2 #1 and the Merensky will feed the proposed FCR Plant for fine chromite beneficiation. A mobile pilot plant will be designed before the actual FCR Plant starts functioning.

Archaetnos cc has been appointed by SRK Consulting South Africa (Pty) Ltd to provide heritage specialist input into the EA process.

The area has been worked by heavy equipment which disturbed the soil. Certain portions of the site are covered by pioneer plant species.

The letter recommends that an archaeologist be contacted by the developer if archaeological material, such as sites, objects and features as well as graves and burials are uncovered during construction, and work to cease immediately.

Final Comment

Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;

38(4)c(ii) – If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Mimi Seetelo 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA
