Final Comment

The Applicant proposes the development of sixteen (16) poultry houses on the farm Vaalkranz close to Winterton in KwaZulu-Natal. Four houses are expected to be built within five years, after which the farmer expects to build a further 12 houses over the following 15 years. Each house will contain a maximum of 33 500 layers, with a maximum housing capacity of 536 000 layers once all houses are operational. Each of the two locations will have packing room (20 x 25m) with a wash bay and 1000kVA transformer which will power the houses and associated infrastructure.

The Basic Information Document, Heritage Impact Asssessment Study by Jean Beater and the Palaeontological Study by Marion Bramford submitted in support of the application for comment as outlined above have been considered in formulating decision. The HIA provides a list of heritage resources in the category of graves identified during the survey, level of impact as well as suitable recommendations and mitigation measures in Sections 7,8,9 and 10 of the report. We concur with the recommendations but further require monitoring by the heritage practitioner to ensure that the identified resources and any other chance finds are not compromised by the development activities. The HIA practitioner is required to assist with demarcating the appropriate buffers to ensure that the resources are not compromised. The recommendations outlined in the Palaeontological report should be adhered to.

The KwaZulu Natal Amafa and Research Institute, (Formerly Amafa aKwaZulu Natal, Heritage KwaZulu Natal, Erfernis KwaZulu Natal), therefore has no objection to the proposed development within limits of the stipulated conditions and mitigation measures.
