## Interim Comment

In terms of Section 38(8) of the National Heritage Resources Act (Act 25 of 1999) and the KwaZulu-Natal Heritage Act (Act 4 of 2008)

**The proposed development is targeted toward the small N4 informal settlement in Umlazi. The proposed laid pipes (water and sewer) will tie-into existing reticulation and will provide future reticulation when the area is developed. There is a single CAB site located at 29°57'31.25"S, 30°52'36.48"E. The informal settlement is located amidst a medium density formal residential area (RDP) thus a single CAB site containing one male and one female block, is adequate to service the need for water and sanitation within this settlement.**

A Heritage Impact Assessment is required as there is a high probability of impacting on heritage resources. The HIA should include a public participation component on presents of otherwise of informal graves.

Amafa KZN Heritage therefore requires the appointment of an Amafa accredited Heritage Practitioner to assist in the provision of recommendations and mitigation procedures.
