## Unauthorized Additions and Alterations on Portion 1 of Erf 517 Brickfield being at 11 Palm Grove, Durban.

Please be advised as follows: -

(1) The Institute was unable to consider the merits of the application as the work had already commenced, alternatively, has been completed;

(2) As a result, a permit cannot now be issued;

(3) We would like to draw your attention to the fact that your failure to obtain a permit prior to the commencement of the work, is in contravention of the provisions of the KwaZulu-Natal Amafa and Research Institute Act (5 of 2018), and as such is a criminal offence for which you may be prosecuted;

(4) However, the Institute has decided to condone your failure to obtain a permit, as required, on condition that the work was conducted strictly in accordance with **drawing dated 20/10/2023**, **drawn by N. Shamoun, received by the Institute on 08 December 2022, property graded Not**
