The SAHRA Archaeology, Palaeontology, Meteorites, Heritage Objects and Burials permit committee has received your application requesting a new destruction permit for site 02Woon for which an expiry permit had already lapsed at the end of July 2014.

The site was mitigated in 2013 (Permit ID\_164) and a permit report submitted in February 2013. A destruction permit (ID\_317) had already been issued for this site in July 2013 and expired at the end of July 2014. Since the destruction of the site has not occurred yet, SAHRA requested that Mr Nel apply for a new destruction permit.

Because of the nature of the mining activities, it is expected that the destruction of the site will take longer than one year. For this reason, SAHRA agreed in issuing a permit for five years, renewable for a further five years.
