The KZN Department of Transport proposes to extend and upgrade the existing L1867 road from a mud track to a type 7A Local Gravel Road. The road will be approximately 13.620 km in length and 6 m in width with a road reserve of 20 m which confirms to the Department of Transport standards. The road transverses a watercourse therefore the Department of Transport proposes to construct a standard causeway structure to allow the continuance of the natural flow of the water.

Thank you for notifying us about this development as required in terms of Section 38 of the heritage legislation and NEMA. The proposed development is likely to impact on heritage resources directly and indirectly as a result of this development as it is located in an area that is known for yielding culturally sensitive findings due to its history of association with human activity.
