SAHRA BGG has received and reviewed your Grave Exhumation and Relocation Report and therefore wish to place the following on record:

- 1. SAHRA does not support mass burials. We do recognize that the graves in question fall outside our mandate and that we do not have much control over how they are handled. However, we wish to advice that graves protected in terms of our legislation must always be buried in dignity, according to the wishes of the identified next-of-kin and in line with the principles of heritage resources management.
- 2. We are pleased with the manner in which the grave protected under section 36(3) of the NHRA was handled.

In light of the above, this case is hereby closed. Should there be any future grievances relating to the mass buried graves, this must be handled by the relevant stakeholders in terms of the Human Tissue Act.
