Final Comment

The activity entails the development of a 132kV single-circuit power line to enable the connection of the authorised Sonvanger Photovoltaic Solar Power Plant (DFFE ref.: 14/12/16/3/3/2/672) to the national grid network. This will enable the evacuation of the generated solar electricity. A 200m wide and 22km long grid connection corridor is being assessed for the placement of the power line route. The power line is proposed to connect into the existing Oryx-Joel 132kV Line. A service road associated with the power line is also proposed to be developed. The activity entails the development of a power line which will be single circuit and have a capacity of 132kV. The power line will connect to the existing Oryx-Joel 132kV Line via a loop-in loop-out connection and will enable the evacuation of the generated electricity from the authorised Sonvanger Photovoltaic Solar Power Plant. The project is proposed by Pele Green Energy (Pty) Ltd.

Management Act (NEMA; No. 107 1998) and the 2014 NEMA EIA Regulations. The corridor for the proposed powerline is 200m wide and 22km in length which will be along an existing road that runs through land that has been extensively transformed through agricultural activities.

CTS Heritage, 2021, Proposed development of the Sonvanger OHL near Theunissen in the Free State

In Heritage Impact Assessments completed for developments in the broader region including the study area indicate that there are formal cemeteries, historic structures as well as scatters of Middle and Later Stone Age lithics. There is modern demarcated municipal cemetery located within the powerline corridor. It remains possible that burials may be located outside of the cemetery and within the power line corridor, impact to these sites can be avoided through strategic placement of the pylons. It is not anticipated that the proposed development will negatively impact on any significant heritage resources and it is recommended that no further heritage studies are required for this proposed development. A Chance Fossil Finds Procedure must be implemented for the duration of construction activities

Bamford, M, 2021. Desktop Study (Phase 1): Palaeontological Impact Assessment for the proposed Sonvanger Overhead Transmission Line, Theunissen, Free State Province

The study area is underlain in the northern section by Quaternary sands, alluvium and calcretes which may contain traps for fossils such as paleo-pans or palaeo-springs. No such feature is visible on the satellite imagery. The southern half is on non-fossiliferous dolerite of Jurassic age. A Chance Finds Protocol has been attached. If fossils are found once excavations for the foundations for the poles and amenities have commenced then they should be rescued and a palaeontologist called to assess and collect a representative sample.
