Eskom has been requested by Greater Taung Local Municipality to electrifiy 100 houses at Ranstad Ext village. Among the proposed house connections, there are houses that have existing electricity. However, due to the orientation and unrealibility of the existing infrastructure, the houses will be reconnected on the new grid, and the old infrastructure will be dismantled. The proposed development will entail construction of 22kV (Medium Voltage) power line of approximately 1157m, construct Low Voltage and connect houses. The proposed development falls within the Greater Taung Local Munic in North West province.

Eskom Distribution North West Operating Unit has been request by the Greater Taung Local Municipality to elective 100 households at Ranstad Ext Village.

The scope of work entails the construction of a 22kV (Medium Voltage) power line of approximately 1157m and the connection of houses. The scope of work will also include the dismantling of old infrstructure to reconnect houses to the new grid.

A DESD has been sumbitted with the application and no known heritage resources have been identified within the development foot print.

The power line will in some areas run through vegetated areas and along the Harts River. Water sources are common sites of Later Stone Age archaeological material. The project cuts across areas of moderate and low palaeontological sensitivity.

Final Decision

As the new line will be built in a disturbed area and there are likely no *in-situ* heritage resources, no further assessment of the impact to heritage resources is required as per section 38(2)a of the NHRA.

 or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued
 by SAHRA.
