The establishment of a 54m high lattice mast – T8954 Grasdal Farm

Thank you for the notification that development is to take place in this area.

In terms of the National Heritage Resources Act, no 25 of 1999, heritage resources, including archaeological or palaeontological sites over 100 years old, graves older than 60 years, structures older than 60 years are protected. They may not be disturbed without a permit from the relevant heritage resources authority. This means that before such sites are disturbed by development it is incumbent on the developer to ensure that a Heritage Impact Assessment is done. This must include the archaeological component (Phase 1) and any other applicable heritage components. Appropriate (Phase 2) mitigation, which involves recording, sampling and dating sites that are to be destroyed, must be done as required.

Any other heritage resources that may be impacted such as built structures over 60 years old, sites of cultural significance associated with oral histories, burial grounds and graves, graves of victims of conflict, and cultural landscapes or views must also be assessed.

Decision:

After reviewing the Final BAR Report SAHRA is satisfied that no further action is required in terms of the National Heritage Resources Act, (Act no. 25 of 1999). However, please note that if any evidence of archaeological/palaeontological sites or artefacts, or other heritage resources are found during construction activities, the SAHRA APM Unit (Mrs. Colette Scheermeyer, or Mr. Phillip Hine, tel: 021 462 4502) must be alerted immediately, and a professional archaeologist/palaeontologist dependent on the resource must be contacted as soon as possible to inspect the findings at the cost of the developer. If the newly discovered heritage resources prove to be of archaeological/palaeontological significance, then a Phase 2 rescue operation might be necessary at the cost of the developer.
