Interim Comment

In terms of Section 38(8) of the National Heritage Resources Act (Act 25 of 1999) and the KwaZulu-Natal Heritage Act (Act 4 of 2008)

Proposed Construction of Gugulethu Piggery for 600 saws on Farm no. 17601 Oliviershoek, Bergville, Okhahlamba Local Municipality, Uthukela District Municipality, KwaZulu-Natal. The Piggery shall house 600 sows in 3 separate sheds namely Furrowing and Weaner house, Gestation house and Grower house, at Gugulethu rural area. The Piggery shall consist of Piggery Houses, 60 cu.m fresh water storage in Jojo tanks, 40 cu.m of waste water temporal storage Jojo tanks.

The application for comment in terms of heritage legislation as cited above has been considered. The database indicates that the general area of proposed development is highly sensitive in terms of heritage values as it is a rich archaeological, historical and paleontological zone. The proposed development area has not been adequately covered in terms of coverage rating ascribed to a report polygon.

For this reason a field-survey based Phase 1 Heritage Impact Assessment is required . Since the nature of heritage resources expected in this region stretches from the archaeological era to the historical period, the HIA should cover the Historical , Archaeological and Paleontological components. It is noted that an archaeologist will be able to cover both the historical and archaeological components . The paleontological sensitivity of the area is very high and a fieldbased study is required.

The Study should cover:

- Identification of all heritage resources in the development area and its surroundings -50m
- · Assessment of the impact of the development on such heritage
- Evaluation of the impact of the development on heritage resources relative to the sustainable social and economic benefits to be derived from the development
- Results of consultation with communities affected by the proposed development and other interested and affected parties regarding the impact of the development on heritage resources.
- Consideration of alternatives if heritage resources are affected by the development
- Mitigation plans for any adverse effects during and after completion of the project
- Table of all heritage resources identified .This should show Heritage resource type, description, location, significance and reasons for this rating.

The survey should cover more than 50m radius of the proposed site .
