Coal and clay mining right application on portion of portion 6 of the farm Paardeplaats 380 JT in the eMakhazeni Local Municipality, Mpumalanga

Thank you for notifying the SAHRA on the Environmental Authorisation application for the proposed mining of coal and clay on a portion of portion 6 of the farm Paardeplaats 380 JT, Belfast Magisterial District, Mpumalanga Province. The open pit mining method will be used to extract the coal.

As the proposed development is undergoing an EA Application process in terms of the National Environmental Management Act, 107 of 1998 (NEMA), NEMA Environmental Impact Assessment (EIA) Regulations for activities that trigger the Mineral and Petroleum Resources Development Act, No 28 of 2002 (MPRDA)(As amended), it is incumbent on the developer to ensure that a Heritage Impact Assessment (HIA) is done as per section 38(3) and 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA). This must include an archaeological component, palaeontological component and any other applicable heritage components. The HIA must be conducted as part of the EA Application in terms of NEMA and the NEMA EIA Regulations.

The archaeological component of the HIA should follow the SAHRA 2007 Minimum Standards: Archaeological Component of Impact Assessment Report. The quickest process to follow for the archaeological component would be to contract a qualified archaeologist (see www.asapa.co.za or www.asapa.co.za

The placemark in the .kml file attached to the case is pined to the KwaZulu Natal Province, therefore another simple .kml file that outlines the development area must be attached to the case. A field-based Palaeontological Impact Assessment (PIA) must be undertaken by a qualified palaeontologist (See https://www.palaeosa.org/heritage-practitioners.html for a list of qualified palaeontologists), because it is highly likely for fossils to be discovered when mining for coal and clay. The report must comply with the 2012 Minimum Standards: Palaeontological Components of Heritage Impact Assessments.

Any other heritage resources as defined in section 3 of the NHRA that may be impacted, such as built structures over 60 years old, sites of cultural significance associated with oral histories, burial grounds and graves, graves of victims of conflict, and cultural landscapes or viewscapes must also be assessed.
