APPLICATION FOR DESTRUCTION OF LIA STONE WALLING: Portion 10 of the Farm Kopleegte No 1154, near Colenso, Okhahlamba Local Municipality, Uthukela District, Kwazulu-Natal (CASE ID 10465)

On 26 January 2016 Amafa commented on the proposed conversion of grazing land to agricultural land. Our letter clearly states the cultural significance of the area, the aim being to protect the sites in this landscape (Attachment I).

The conditions set for this development stipulated:

- That a proper management plan was to be lodged with Amafa before development proceeds. This has not been lodged.
- The pivots are to be placed as agreed. According to communication dd 11 January 2016 between Susan Carter-Brown (owner of "NatureStamp") and Edu Boettiger ("Irritech), none of the wheel tracks of the pivots would intersect the heritage sites or their buffers (Attachment II). Amafa's approval for the development was based on the placement of the pivots where they would not impact on the stone walling and graves.

BURIALS

"All graves need to be adequately demarcated. The archaeological graves could be excavated; however, the graves dating to the last 100 years would require further investigation and social consultation. It would be a better option place a buffer around the graves. All graves are required to have a 5m buffer between the grave and the edge of the form of demarcation. I would recommend metal fence poles that are high enough to be seen over the crop. There also needs to be a 20m buffer between the grave(s) and the development. An alternative to buffering would be excavating the graves. However, given the space constraints on this project I would support a decreased 20m buffer provided that the sites are clearly demarcated. The excavations undertaken by Anderson and Anderson (2011) clearly show that none of the excavated graves had any human remains. I would support only a 5m buffer around all the graves and other features".

The above section in italics is quoted from the 2015 HIA by Gavin Anderson. The section highlighted in red, together with Table 2, p34 of the same report, did not clearly indicate that grave removal was to take place. The only mitigation required, as suggested by Mr Anderson in this Table, was that of demarcation. Amafa's decision to approve the development was based on this, along with the re-alignment of the pivots.

Furthermore the AmaBhele community will need to be consulted and Amafa supplied with proof of the public participation process, since they had expressed concern about their ancestral graves on the property.

If the original proposed position of the pivot points has altered, and development will now impact on the stone walling, Amafa will have to reconsider the original decision of no objection.

Based on the above, Amafa cannot at present consider the approval of either destruction permits or exhumation/excavation permits until the issues above has been clarified and attended to.

During the site visit on 13 January 2016, some of the engraved stones referred to by F Prins could not be shown to Ms A van de Venter-Radford. There are signs of disturbance, e.g aardvark holes, and it would therefore be impossible to conclude whether the stones, if present, were removed by human or animal actions.

The general area is culturally significant. The long-term aim would be to protect the significance of sites in this landscape that extends beyond the boundaries of this farm.

We are, however, satisfied that the management suggestions proposed by G Anderson would suffice in affording the sites protection, especially since we have been notified that the pivots from the irrigation scheme will be placed in such a manner as not to impact on these sites.

We therefore have no objections to this development, on the following conditions:

- The management suggestions by G Anderson form the basis of a proper management plan to be lodged with Amafa before the development proceeds.
- The pivots are placed as agreed.
- Amafa will endeavour to seek the means to fund the digital recording and mapping of the entire cultural landscape associated with these sites.
- Amafa will encourage applicable researchers to conduct research on these sites and others associated with the cultural landscape. The landowner must therefore commit to allow access.
- Amafa will conduct public information sessions on the management of sites, such as these, with the current owner and owners of similar sites in the area which form part of the cultural landscape.






