Thank you for your request to extend your SAHRA issued permit to continue with the permanent export of 23 enamel samples (5 mg per specimen) from the Beaumont collection (McGregor Museum) and 3 x 300g sediment samples taken from excavation buckets from the excavations carried out under a SAHRA Permit 2916 at Pniel 6. The parameters of the study have not changed and the McGregor Museum has confirmed its support for the contibuation and extension of the permit. SAHRA notes that the analysis will be done at the Leibniz Laboratory for Stable Isotope Research, University of Kiel.
