The author states that the facility lies on flat terrain with very few heritage resources, and that the primary concern is palaeontology. A pre-construction site inspection must be done by a palaeontologist once final layouts have been determined and prior to construction in order to pin-point any particular areas of concern so that these can be monitored during construction if required. The identified Stone Age archaeological resources have low heritage significance and thus do not require mitigation or avoidance.
